

ORDINANCE 89-18

AN ORDINANCE REMOVING AND SEPARATING THE POLICE AND FIRE EMPLOYEES OF THE CITY OF NORTH MIAMI BEACH FROM THE RETIREMENT PLAN FOR GENERAL EMPLOYEES OF THE CITY OF NORTH MIAMI BEACH AND CREATING A NEW PLAN SOLELY FOR QUALIFIED POLICE OFFICERS AND FIREFIGHTERS, ENTITLED "RETIREMENT PLAN FOR POLICE OFFICERS AND FIREFIGHTERS OF THE CITY OF NORTH MIAMI BEACH;" PROVIDING FOR THE REPEAL OF ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HERewith; PROVIDING FOR THE CODIFICATION OF THIS ORDINANCE.

WHEREAS, fire and police employees of the City of North Miami Beach are currently included in the pension plan for all employees of the City; and

WHEREAS, the City Manager of the City of North Miami Beach has recommended the creation of the new and separate pension plan for police officers and firefighters; and

WHEREAS, the retirement committee of the City of North Miami Beach has approved the adoption of the "Retirement Plan for Police Officers and Firefighters of the City of North Miami Beach;" and

WHEREAS, the police officers and firefighters of the City of North Miami Beach have voted to accept all accountings to date in exchange for the establishment of a new pension plan for police officers and firefighters pursuant to Chapters 175 and 185 Florida Statutes; and

WHEREAS, the Mayor and City Council of the City of North Miami Beach have the power to establish a pension plan for city employees pursuant to Section 81 of the Charter of the City of North Miami Beach; and

WHEREAS, the Mayor and City Council have determined that it is in the best interest of the citizens of this city to create a new plan entitled "Retirement Plan for Police Officers and Firefighters of the City of North Miami Beach."

NOW, THEREFORE,

BE IT ORDAINED by the City Council of the City of North Miami Beach, Florida.

Section 1. The foregoing recitals are true and correct.

Section 2. There is hereby adopted the "Retirement Plan for Police Officers and Firefighters of the City of North Miami Beach" effective January 1, 1990 as more particularly set forth in the exhibit attached hereto and made a part hereof by reference as though set forth herein.

Section 3. All ordinances or parts of ordinances in conflict herewith be and the same are hereby repealed.

Section 4. If any section, subsection, clause or provision of this Ordinance is held invalid, the remainder shall not be affected by such invalidity.

Section 5. It is the intention of the City Council of the City of North Miami Beach and it is hereby ordained that the provisions of this Ordinance shall become and be made a part of the Code of Ordinances of the City of North Miami Beach, Florida. The Sections of this Ordinance may be renumbered or relettered to accomplish this intention and the word "Ordinance" may be changed to "Section", "Article", or other appropriate word as the Codifier may deem fit.
