## ARREST MADE IN MULTIPLE SMASH AND GRAB BURGLARIES

On Thursday February 20<sup>th</sup>, at approximately 3:00 AM, police units responded to multiple burglar alarms at a shopping center in the 13700 block of Biscayne Blvd. Upon arrival, police found that six stores in the shopping center had been burglarized by someone smashing out the front windows of the stores using a large rock.

Video surveillance footage from one of the stores was obtained and reviewed by police that clearly revealed the suspect throwing a rock through the front window of one of the businesses. Detectives quickly identified the suspect seen in the video as a local gang member named Alfredo Rey. The detective's investigation also revealed that Rey had been released from prison in December 2013 after being sentenced to four years for committing burglary, grant theft and tampering with a witness.

Once identified, Alfredo Rey, DOB 03/12/1984, was subsequently apprehended and charged with the following:
