- 4. On May 10, 2010, Mr. Burns filed the Appointment of Campaign Treasurer and Designation of Campaign Depository with the Division. Mr. Burns appointed himself treasurer.
- 5. The following reports have outstanding assessed fines: 2010 F1 and F2.
- 6. The following reports have not been file: 2010 F3 and Termination Report (TR).
- 7. On July 26, 2010, the Division mailed Mr. Burns a letter notifying him a fine in the amount of \$50 had been assessed for failing to timely file the 2010 F1 report due July 23, 2010.

- 16. As of March 15, 2011, the reports at issue have not been filed and the fines remain outstanding.


