## NARRATIVE

On 03/12/2011, at approximately 1334 hours, I was dispatched to 2120 NE 171 St. (residence) in reference to a disturbance at Councilman Frantz Pierre's residence. Upon arrival I made contact with Frantz Pierre (reporter 2), he advised me that Ketley Joachim was at his residence harassing his wife Maire Pierre (reporter #1). I made contact with Marie who advised me, while she was sleeping two mknown juveniles knocked on the front door waking her up, she did not answer the door the juveniles then left a "Ketley Joachim" political campaign pamphlet on her door knob. Marie opened the door and told the juveniles as they were leaving that Council Frantz lives here and why are they placing political campaign pamphlets on her door and told the juveniles not to come back. Several minutes later there was another knock on the front door. She looked out the window and observed Ketley Joachim standing in front of her door, she did not open the door at which time she heard Ketley yelling obscenities. Marie further advised me that Ketley was taking several photographs of her residence and then left in a white Nissan Pathfinder when Frantz drove up to the residence.

I made contact with Ketley who advised me that she was going door to door in the area passing out her political campaign pamphlet and was not aware that she was knocking on Councilman Pierre residence. Ketley further advised me that she had several juveniles passing out her pamphlets when a black female at the councilman's residence began yelling obscenities at the juveniles. She got in her vehicle and began to drive off when Councilman Frantz drove up.

Marie and Frantz Pierre were issued a case number and advised of their legal rights. They were also advised on the process for filing for a restraining order. Ketley was also issued a case number.
