ORDERED AND ADJUDGED that Plaintiff, CIT Technology Financing Services, Inc., a Massachusetts corporation, have and shall recover from DEFENDANT DPI DIGITAL PRINTERS INTERNATIONAL, INC. damages in the principal sum of \$59,235.34, prejudgment interest from December 16, 2008 through August 12, 2009 in the amount of \$3,102.22, attorneys' fees and costs of \$1,893.50 for a total of \$64,123.06 as of August 12, 2009 that shall bear interest at the rate of eight (8%) percent per annum from and after August 13, 2009, for which let execution issue forthwith.
