Dear Patsy:

Thank you for taking my call. I found out that my Complaint was received by your office on April 13, 2011 at 9:55 a.m. and signed by R. Mathis. I hope you find it. The FedEx rep I spoke with did not have the tracking number because I lost my copy and couldn't give it to him, but I will get it once my bill comes in if you need it.

I have attached only the Confidential Complaint Form itself without the attachments, which are numerous, because I'm hoping you find the original. If not, please let me know and I'll send you the entire document.

In order to amend my Complaint, I am also attaching a copy of Myron Rosner's Memo to the City Clerk, and his amended Campaign Treasurer's Report, which he filed on April 15, 2011. This report shows that the amount he claims he eventually paid for the advertising but neglected to file on his original return, was \$4,500.00, which is over \$15,000.00 below market value. In addition, he claims he wrote this check on January 25, 2011 but it just so happened it didn't clear until April 13, 2011 (two days after I filed my complaint with you and with the Miami State Attorney). It is my understanding that a candidate cannot write a check without cleared funds in his account and cover it at a later date. In addition, his amended return shows a shortfall between his Total Monetary Contributions To Date and his Total Monetary Expenditures to Date of \$2,063.74.

He also produced a new loan from himself to his campaign in order to cover this check, however, he did not report this new loan until his Campaign Treasurer's Report of April 14, 2011. I have attached a copy of the front page of same.

This is the information I have so far on this candidate, who I believe has violated many Florida Election Laws. I am hoping the Florida Elections Commission will investigate and take action.





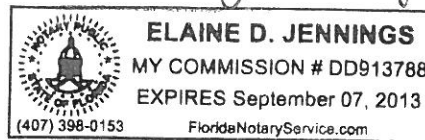
