This candidate has committed several violations:

- 1. The candidate filed to run for office on May 8, 2014 in the name of "Carline Marie Paul" (see attached Statement of Candidate), yet she is advertising herself as "Teacher Carline," which is NOT the name of the candidate.
- 2. The candidate is advertising herself as a "teacher," however, she is NOT a teacher.
- 3. The candidate's Campaign Treasurer Reports (CTRs) have a multitude of errors:
 - a. She filed her first reporting period on May 21, 2014 reflecting contributions of \$1,145.00. (See attached CTR dated 5/21/14)
 - b. She then filed an amended report on July 2, 2014, correcting the contributions by hand to reflect a new amount of \$1,119.33; however, she did not change Line (9) to reflect the corrected total. On this amended CTR, she reflected expenditures of \$25.67, but does not attach an itemized expenditure schedule. (See attached amended CTR dated 5/23/14)
 - c. The candidate filed a CTR for the reporting period ending June 30, 2014. She reflected contributions of \$1,000.00; however this was a LOAN, and not a contribution. Also, on Lines (9) and (10), she did not list the total balances of contributions and expenses. (See attached CTR dated 6/30/14.
 - d. The candidate filed a CTR for the period ending July 30, 2014, as required. (See attached CTR dated 7/30/14)
 - e. The candidate filed a CTR for the period ending August 31, 2014, as required. (See attached CTR dated 8/31/14)
 - f. The candidate did <u>NOT</u> file the required report for the period ending September 30, 2014.
 - g. The candidate filed a CTR for the period ending October 31, 2014, as required. (See attached CTR dated 10/31/14)
 - h. The candidate filed a CTR for the period ending November 30, 2014, reflecting a contribution of \$100.00; however, the total contributions listed on Line (9) is incorrectly stated as \$3,399.33, when the actual total is \$3,259.33. (See attached CTR dated 11/30/14)
 - i. The candidate filed a CTR for the period ending December 30, 2014, carrying forward on Line (9) the INCORRECT total of \$3,399.33. (See attached CTR dated 12/30/14)
 - j. The candidate filed a CTR for the period ending January 31, 2015, carrying forward on Line (9) the INCORRECT total of \$3,399.33. The candidate also lists additional expenditures of \$500.00, **but did not attach an itemized expenditure schedule**. (See attached CTR dated 01/31/15)
 - k. The candidate filed a CTR for the period ending February 28, 2015, carrying forward on Line (9) the INCORRECT total of \$3,399.33. The candidate also lists additional expenditures of \$675.00, **but did not attach an itemized expenditure schedule**. (See attached CTR dated 02/28/15)
