Once the insurance company determines that the complaint falls into the description of coverage, a confirmation letter is sent to us acknowledging coverage or not. The series of claims in your email were sent to the insurance company by either myself or the County Attorney or a combination thereof.

As to the County's Insurance premium of \$938,403.00, that is a combined amount from a combination of Auto, general liability, crime, inland marine, Public officials/employment practices liability and property insurance coverage. The person that signs the documents each year is the County Administrator by direction of the board.
