THE DEFENDANT'S WIFE CONTACTED THE POLICE TO SERVE THE DEFENDANT WITH A TEMPORARY INJUNCTION FOR PROTECTION AGAINST DOMESTIC VIOLENCE (CASE#2016-030443-FC-04). OFFICERS LAGUERRE AND BAEZ RESPONDED TO THE DEFENDANT'S HOME, AND AS THEY SERVED THE INJUNCTION, THE DEFENDANT PULLED A HANDGUN AND BEGAN SHOOTING AT THE OFFICERS. BOTH OFFICERS RETURNED FIRE AND TACTICALLY RETREATED OUTSIDE OF THE HOME. THE OFFICERS WERE NOT INJURED.
