

DAUGHTER (LISETTE YUEN) WHO ARRIVED SHORTLY AFTER I DID. AT APPROXIMATELY 2145 HOURS, AS I WAS PREPARING DOMESTIC VIOLENCE PAMPHLET, I OBSERVED THE SUBJECT WALKING TOWARD THE RESIDENCES FROM THE NORTH ON NE 11PL. AS I ATTEMPTED TO MAKE CONTACT WITH HER, SUBJECT FLED FROM ME TOWARD THE BACKYARD OF THE HOME. JUST AS THIS OCCURRED, TWO CRISIS COUSELORS (WITNESS 2 & 3) FROM SPECTRUM, ARRIVED ON THE SCENE IN A WHITE VAN. AS I STARTED TO WALK TOWARDS THE BACKYARD OF THE RESIDENCE, WITNESS #1 ADVISED ME TO BE CAREFUL AS THE SUBJECT BECOMES VERY VIOLENT. I THEN REQUESTED WITNESS #2 & 3 TO ACCOMPANY ME TO THE BACKYARD AND REQUESTED POLICE BACK-UP FROM NORTH MIAMI PD. WHILE IN THE BACKYARD, I COULD HEAR THE SUBJECT INSIDE A TOOL SHED. AS I WAITED FOR ADDITIONAL POLICE UNITS, SUBJECT RAN OUT OF THE SHED IN AN ATTEMPT TO FLEE AGAIN. I REACHED FOR THE SUBJECT, GRABBED HER HAIR, AND DIRECTED HER DOWN TO THE GROUND. AS I ATTEMPTED TO HANDCUFF THE DEFENDANT, SHE GRABBED ME BY THE TESTICLES WHILE TRYING TO BITE ME AT THE SAME TIME. I STRUCK THE DEFENDANT SEVERAL TIME IN THE FACE AREA UNTIL SHE RELEASED ME AND I WAS ABLE TO HANDCUFF BOTH HANDS. DEFENDANT WAS ARRESTED, TRANSPORTED TO AVENTURE HOSPITAL VIA MDFD RESCUE 20, AND THEN TO TKG.
