II. Respondent's reason for personal harm. Chief Eugene stated in a U-Tube interview that he wants the department to "mirror the community," which is primarily Haitian and Hispanic. He also stated in a meeting with the command staff that the promotions "were not based on performance." The police department has a history of discrimination against whites in promotions. III. Discrimination statement.
