

APRIL 6, 2010 MEETING MINUTES

1. ROLL CALL OF THE CITY OFFICIALS

Motion made by Councilman Derose, seconded by Vice Mayor Smith, to approve the expenditures of \$1,038,500.00 from the Federal (Justice) Law Enforcement Fund and \$297,000.00 from the State/Local Law Enforcement Trust Fund. In a voice vote, all voted in favor. **(Motion carried 7-0)**

8.2 Update of Miscellaneous Items

City Manager Baker reported that the City is currently in the second week of the Census. Tonight we are unveiling a special program as part of our Census initiatives; it's entitled, "I've Been Counted." He encouraged each Council Member to wear the "I've Been Counted" pins and to encourage residents to also wear these pins, in an effort to encourage the rest of the community to join us.

City Manager Baker reported that the percentages of the communities counted to date are:

- Eastern Shores – 49%
- Highland Village – 42%
- Sunray East – 40%
- Sunray West – 53%
- Windward and Pickwick – 47%
- Uleta – 48%
- Oak Grove – 45%
- Allen Park and Fleeman Height – 45%
- Washington Park – 45%
- Skylake – 60%

The overall average is 47.4%. Our goal is reach the 60% percentile by the end of the week. In 2000 we only had a 60% response rate. The City has begun going door-to-door and urging the communities to turn in their reports. He stated that one thing that is unique about North Miami Beach is that over 50% of the North Miami Beach community is foreign born, which makes these efforts more challenging than in other communities; but, the City is confident that we will reach the 60% goal by the end of this week and urged the community to join in the City's efforts.

City Manager Baker reported on the soccer program that was discussed at the last Council meeting, stating that the City has had a couple of meetings with them and we are working on something that will ultimately be very favorable for the community. Once that plan is completed, he stated that he will report back to the Council. So far, they are pleased with the route we are taking.

City Manager Baker reported that about a week and a half ago he had gone to Tallahassee to drop off numerous grant proposals. This afternoon he received a phone call indicating that

several of the proposals are being considered. Once the official reports are received he will report back to the Council.

City Manager Baker introduced the new Code Enforcement Manager, Mr. Ken Pieslak. Mr. Pieslak addressed the City Council and expressed his gratitude to be able to serve and to be able to work with the City team and with the citizens of North Miami Beach.

Mayor Rosner asked the City Manager to address the second Census mailer that residents have been receiving and to clarify who can be counted in a residence.

On behalf of the City Manger, Assistant City Manager Bernard McGriff responded that if residents happen to get a second Census mailer, they should not send the form in if they have already done so. If residents forget to put someone on their Census form, then they can add the person to the second form and mail it back.

Councilwoman Kramer asked for an update on the Homeless Trust Meter.

City Manager Baker responded that he had been on the phone with Ron Book earlier today, and that Mr. Book is assisting the City in expediting the process. The meter has been ordered and is in the process of being manufactured, which takes about two months.

Councilman Julien stated that the Census's practice of not allowing people to count children who are away at college is wrong. Vice Mayor Smith pointed out that they will be counted wherever their college is. Councilwoman Spiegel stated that doesn't help us; that is one more person counted for another city, and one less person counted for our city.

City Manager Baker responded that his guess is that if they are not being counted where they are, they need to be counted here.

Councilman Julien stated that this is something that needs to be addressed.

City Manager Baker responded that we will address that with the Census representatives.

Vice Mayor Smith indicated that she is putting her Census shirt on because she wants to volunteer on April 10th when they are going to start walking door-to-door.

City Manager Baker spoke regarding the proposed schedule for the 2010 groundbreaking and ribbon cutting events. He stated that for each event there will be a specific theme. He announced that one event has been added, per the Council's directive; this is the Children's Room at the North Miami Beach Library which we are dedicating to former Councilwoman Jacqueline Smith.

9. CITY ATTORNEY'S REPORT – Darcee S. Siegel

City Attorney Siegel reported that since the Council had received their litigation lists, a new litigation case has been received for a police shooting that occurred on November 30, 2008. The City, the Police Department, the Police Chief – in both his official and individual capacities, and Sergeant Nelson Reyes are being sued. She stated that she will be providing periodic updates on the

case.

City Attorney Siegel gave an overview of the ordinances which are up for first reading this evening. The first item involves the rezoning of 1590 NE 162nd Street, which is currently occupied by G & G Holistic Group. They have been occupying and conducting business at that location for approximately five years. The rezoning is being requested because the business at that location is not a permitted or a conditional permitted use. The Planning and Zoning Board is unanimously recommending approval of this rezoning. If this ordinance is passed on April 20th, then a resolution to approve a conditional permitted use with certain conditions will be submitted to the City Council. The Planning and Zoning Board is also recommending approval of this conditional permitted use and its conditions.

The second ordinance is in reference to the hours of sale of alcoholic beverages. The current ordinance makes no mention of sales on Saturdays; this was inadvertently left out years ago. This ordinance cleans things up and gives Saturday the same status as a weekday. The current ordinance states that package stores are not allowed to sell any alcoholic beverages between 4:00 A.M. – 1:00 P.M., that will stay the same. The current ordinance also left out any mention of wine. Tonight's ordinance will also allow for the sale of beer and wine for businesses whose primary business is not the sale of alcohol. The Planning and Zoning Board is unanimously recommending approval of this ordinance.

The third ordinance allows for residential home businesses in Eastern Shores. Every other zone in the City allows residential businesses, except for RM-19 and RS-1. The Planning and Zoning Board is unanimously recommending approval of this ordinance also.

City Attorney Siegel announced that she will be bringing before the City Council an amendment to the Code Enforcement Ordinance allowing a Special Magistrate, not just the Code Enforcement Board, to hear matters regarding those conducting business in the City who are delinquent and do not have a Business Tax Receipt.

10. MAYOR'S DISCUSSION

Mayor Rosner reported that the City hosted their First Wheelchair Tennis Tournament this last weekend. There were six out of towners that attended the tournament, one of them is on the United States Tennis Association Board. They were very impressed the way we handled our tournament and are looking forward to telling people about it next year. The Mayor gave a special thanks to Leisure Services, Paulette Murphy, Mr. Finney, and the entire staff. The same thanks was extended for yesterday's ribbon dropping of the Barry Schreiber Park. This is the first boundless playground in the Northern Quadrant of Miami-Dade County. Mayor Rosner reported that all day people in the community had stopped him to say thank you.

Councilwoman Kramer asked the City Council to set a date for the Council Salary Workshop. Councilwoman Spiegel stated that she had suggested that, since the Council will already be together for the Community Redevelopment Agency Meeting from 5:00 P.M. – 7:00 P.M. on April 27th, that the Salary Workshop be scheduled for 7:00 – 9:00 P.M. that same evening. Councilman Julien stated that he was under the impression that a resolution was going to be brought before the City Council. Councilwoman Kramer stated that she doesn't see that happening and that she preferred to hold a workshop before April 27th. Vice Mayor Smith suggested that a resolution be prepared and that the Council can still hold a workshop to take the salary to \$10,000.00 and the rest of the money to be expense. Councilwoman Kramer stated that Councilwoman Spiegel had already proposed that, and none of us voted for it. She further stated that the Council Members all have different opinions on this matter, and that's why we need a workshop. There were unintended consequences with the qualifying fees and the Florida Retirement System contributions that we need to address; and, I think the public should be involved in this. Councilwoman Kramer reiterated Councilwoman Spiegel's suggestion that the workshop be held after the April 27th Community Redevelopment Agency Meeting. Mayor Rosner stated that that meeting's agenda is already very heavy and that he thought it would be difficult to hold the meetings on the same night. He suggested holding it on one of the off Council Meeting Tuesdays in May, either May 11th or May 25th. After further discussion, a tentative date of Tuesday, May 11th was set.

VICE MAYOR SMITH

Explorers. I would like to first congratulate the Explorers. I can tell you I am not surprised, under Tom Carney and the head of the Explorers, everything I have seen them do and I have seen them all over this City many, many, many times. From the beginning till the end, they are not at a top-notch, they are not on a scale of one to ten, they are always a fifteen to twenty and I thank them for their time and their diligence to be expert.

City Progress. To work not only in our budget, but with our public and to make it the best City that anybody would be envious of to live in. That's our goal every single day.

COUNCILWOMAN SPIEGEL

Happy Holidays. No committee reports. I hope everyone had great holidays, if they were celebrating holidays. Go out and enjoy my favorite time of the year. See you in two weeks.

COUNCILMAN JULIEN

Forgiveness. I would like to say that I do not know about anyone else, but the God that I serve preaches tolerance, forgiveness and above all else, forgiveness. If anybody is perfect, I wish I had a pocket full of stones so I could give that person and let them throw the first stone.

Council Members. When did we lose the third Haitian on this Council? I don't know who the third Haitian was that got lost; but, oh well, there are three Haitians on this Council.

Save 509. There is an organization called Save 509. For those of you who don't know, 509 is the area code for Haiti. Save 509, you can go to their website at www.save509.org, they are having a 7K Run/Walk for those who cannot run. It's going to be held this Saturday April 10th, they're asking anybody that wants to sign up to please go to the website. After every kilometer they will recognize one city. And the seven cities that they will be recognizing and all of the money that they

raise will go 100% to Haiti. The first kilometer will go to Jacmel, the second kilometer will go to Leogane, the third kilometer will go to Petit Goave, the fourth kilometer will go to Grand Goave, the fifth kilometer will go to Centre Ville, the sixth kilometer will go to Carrefour, and the seventh and last kilometer will go to Port au Prince. The starting point will be at the Little Haiti Park at 6301 NE 2nd Avenue and the start time is 7:00 A.M. Anyone who is interested, I believe the City of Miami will have 200 uniformed officers participating, they will be donating their time and obviously this is something that they feel very proud of and we encourage everybody to participate.

Eastern Shores. I would like to, Mr. Manager and Madam Clerk, ask that at our next Council Meeting that we invite Mr. Kehren to address the community, primarily because of the situation that has been taking place in Eastern Shores. I know that Mr. Kehren has had meetings with you, Mr. Manager, and possibly the Chief and a few other people in the community and I would like for him to address us.
