IT IS ADJUDGED that Plaintiff JV AUTO, LLC, c/o Robert Bissonnette, Esq., 2810 East Oakland Park Boulevard, Suite 104, Fort Lauderdale, Florida 33306, recover from Defendants PHILIPPE BIEN-AIME ("BIEN-AIME"), c/o Mayor's Office City of North Miami, 776 NE 125 street, North Miami, FL 33161 and of 532 NE 133 Street, North Miami, FL 33161, individually and as Registered Agent of PHIL USED CAR DEALER and AUTO BROKER CORP ("PHIL USED CAR"), and PHIL USED CAR, of 17 South State Road 7, Plantation, FL 33317 the sum of \$55,200 00 for treble damages, the cost of a dishonored check in the amount of \$1,522.50, exclusive of costs and any bank fees incurred as a result thereof, and court costs of \$581 00, making a total judgment of **\$57,303.50**, that shall accrue interest at the legal rate prescribed by *Fla. Stat.* § 55.03 for which let execution issue.
