
FINAL ORDER OF CONTINUING GARNISHMENT AGAINST SALARY OR WAGES

THIS CAUSE having come before this Court on Plaintiff's Motion for Order of Continuing Garnishment Against Salary or Wages and the court having reviewed the pleadings, having determined that the Garnishee, CITY OF NORTH MIAMI, FLORIDA, has been properly served with the Writ of Garnishment and has admitted a debt to Defendant, and Defendant(s), having failed to object thereto or to plead any defenses and the Court being otherwise fully advised in the premises, it is

ORDERED AND ADJUDGED that:

1. Plaintiff's Motion for Order of Continuing Garnishment Against Salary or Wages as to defendant, PHILIPPE BIEN-AIME, is granted.
2. Plaintiff, TIDEWATER FINANCE COMPANY t/a Tidewater Credit Services and Tidewater Motor Credit shall have, receive and recover from Garnishee, CITY OF NORTH MIAMI, FLORIDA, periodic payments in the amount of 25% of the defendant's net disposable pay, due and payable to the plaintiff on the normal payday of the debtor and shall include any amounts owed from the date of service of the Continuing Writ of Garnishment on APRIL 13, 2015, and continuing for so long as Defendant is employed, until such time as Plaintiff's Final Judgment dated May 8, 2014 in the amount of \$2,089.65, plus post judgment costs and post judgment interest is paid in full.
3. All payments **shall be noted with FILE NO. 125172** on the face of the check and made payable to SPRECHMAN & FISHER, P.A. TRUST ACCOUNT; SPRECHMAN & FISHER, P.A., 2775 Sunny Isles Blvd., Suite 100, Miami, Florida 33160-4007.
4. The Clerk of the Court shall pay Garnishee, CITY OF NORTH MIAMI, FLORIDA, the statutory attorney's fee of \$100.00 filed with said Clerk, as the reasonable attorney's fee in this cause..
5. Plaintiff's court costs in the amount of \$215.00 shall be taxed against Defendant, PHILIPPE BIEN-AIME, for all which let execution issue.
