I received a surprising call yesterday from a former employee of the City Attorney Office advising me that one of your investigators is investigating me regarding a meeting that took place between Maggie Gordo and I during my tenure as the City Attorney for the City of Sunny Isles Beach. I was informed that the complaint was filed by current City Attorney Ed Dion. The information was provided by your investigator via a telephone call.

Hopefully, our service on these panels were beneficial to some elected officials. Based on our prior relationship, your investigator could have called me to find out the truth about the perfect meeting that I had with Maggie Gordo, who has dedicated her time to ensuring that City of Sunny Isles Beach is a government for the people, not for special interest.

As I indicated to you previously, you should require complaints to be filed with your office under oath under the penalty of perjury to root out frivolous and retaliatory complaints. I am available anytime to testify under oath to tell you the truth about the City of Sunny Isles Beach in order for your office to stop wasting tax payer funds on bogus complaints. She is against the Infinity project and overdevelopment on the west side of Collins Avenue. In fact, she met with me in early January of 2019 to voice her complaints about the Infinity project and related bridge to that project.
