



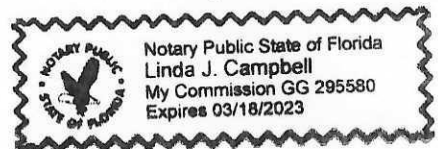

Complaint against North Miami Beach Commissioner Paule Villard

North Miami Beach Commissioner Paule Villard is violating Section 2-11.1 (g), in that she is exploiting her position by using City resources for self-promotional purposes.

Although it is not officially campaign season yet, Villard is running for re-election on November 8, 2022. In the meantime, she has commissioned numerous items at City expense that clearly have the appearance of campaign-like materials. These items are as follows:

1. On 4/20/21, she ordered the attached 230 red non-woven gift totes imprinted with the City logo and "Commissioner Paule Villard," which she distributes at events. Attached is the invoice for these items showing the City was billed the sum of \$393.89.
2. On 6/28/21, she ordered the attached 1,000 blue campaign-like tote bags printed with her photo, the City logo, and the message, "Vice Mayor Paule Villard Thanks YOU for your support." Attached is the invoice for these items showing the City was billed the sum of \$1,830.59.
3. On 7/21/21, she ordered 1,000 promotional "Cubano Pens" (see: <https://www.4imprint.com/product/109148-S/Cubano-Pen-Opaque>). Despite repeated requests for a copy of the artwork for same, the City of North Miami Beach has refused to provide it. According to the attached invoice, the City was billed the sum of \$423.54 plus \$18.54 for shipping.
4. On 8/3/21, she ordered the attached 2-sided 1,000 note cards stating, "Vice Mayor Paule Villard, Public Servant..." According to the attached invoice, these cards cost the City the sum of \$145.00.
5. On 10/4/21, she ordered the attached self-promotional tent emblazoned with her name and the City logo. According to the attached credit card statement, this promotional tent cost the City \$999.86 plus \$274.99. Despite repeated requests for a copy of the invoices for this promotional tent, the City of North Miami Beach has refused to provide same.
6. On 10/24/21, she was seen at an unknown public event wearing the attached campaign-like tee shirt stating, "City of North Miami Beach Commissioner Paule Villard." Despite repeated requests for a copy of the invoices for these campaign-like tee-shirts, the City of North Miami Beach has refused to provide same.

In addition, Paule Villard is exploiting her former position as the temporary appointment as Vice Mayor by continuing to use that title through the present date, despite the fact that her term ended on August 17, 2021.

Please note that at the July 20, 2021 Commission Meeting, according to item 13.1 of the Agenda (see: <https://nmb.novusagenda.com/agendapublic/MeetingView.aspx?MeetingID=1020&MinutesMeetingID=339&doctype=Agenda>) Daniela Jean was slated to be appointed as Vice Mayor, effective August 1, 2021. Paule Villard, however, deliberately broke quorum at that meeting for several reasons, one of which was to delay Commissioner Jean's appointment and extend her own four-month term as Vice Mayor by an additional month. It was not until the August 17, 2021 Commission Meeting that Commissioner Jean was finally appointed according to item 13.1 of the Agenda (see: <https://nmb.novusagenda.com/agendapublic/MeetingView.aspx?MeetingID=1021&MinutesMeetingID=337&doctype=Agenda>)

Even though Commissioner Jean has already completed her four-month term, and at the December 14, 2021 Commission Meeting, Commissioner Fortuna Smukler was appointed for her four-month term as Vice Mayor according to item 13.1 of the Agenda (see: <https://nmb.novusagenda.com/agendapublic/MeetingView.aspx?MeetingID=1025&MinutesMeetingID=-1&doctype=Agenda>), Paule Villard is still exploiting the temporary position of Vice Mayor to this day.

Accordingly, although her four-month term as Vice Mayor was originally scheduled to end on August 1, 2021, she ordered the 1,000 of these campaign-like tote bags (per item #2 above), which she continued to distribute long after her term as Vice Mayor officially ended, thereby exploiting the title of "Vice Mayor," and falsely claiming to still hold that position.

On August 3, 2021, she ordered 1,000 note cards still claiming to be the Vice Mayor (per item #4 above), stacks of which were displayed on tables in the lobby of City Hall for at least a month or more after Daniela Jean was appointed as Vice Mayor.

On December 11, 2021, Paule Villard arranged for another Publix Gift Card Giveaway, during which she handed out the very same campaign-like tote bags with the words, "Vice Mayor Paule Villard Thanks YOU for your support" printed on them, as evidenced by the video posted here: <https://www.youtube.com/watch?v=h3H2swvAKko>

On December 25, 2021, Paule Villard attended an event hosted by radio personality Rotschill Anderson. At said event, she gave out a Proclamation from the City to an entertainer. She read the proclamation publicly, and at the end she stated, ""Signed by Mayor Anthony DeFillipo, VICE MAYOR PAULE VILLARD, Commissioner McKenzie Fleurimond, Commissioner Daniela Jean, Commissioner Michael Joseph, Commissioner Barbara Kramer, Commissioner Fortuna Smukler, and yours truly." This presentation is evidenced by the video posted here: <https://www.youtube.com/watch?v=sNv-lq29AfA>

In actuality, the Proclamation dated December 25, 2021, a copy of which I obtained by public records request, states that the Vice Mayor is, in fact, Fortuna Smukler. By deliberately misreading the Proclamation in a public setting, Paule Villard is continuing to exploit her former temporary position as Vice Mayor.

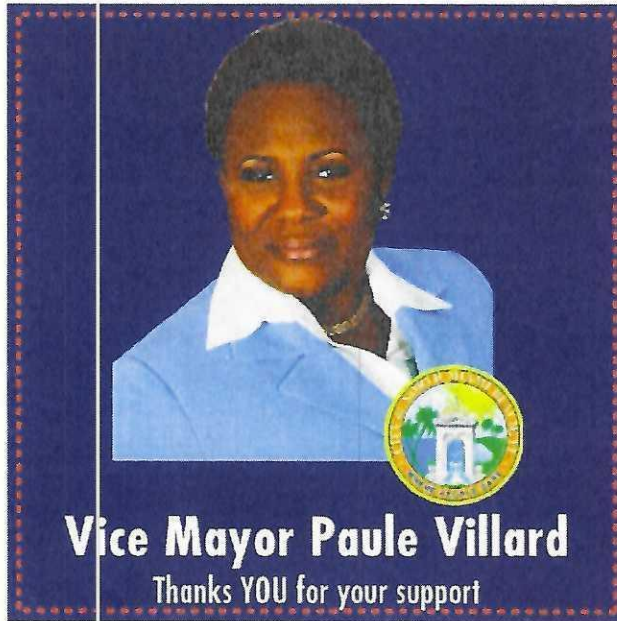

WHEREAS, MIKABEN is a versatile and eclectic artist with a wide range of talents as a writer, composer, producer, singer in the languages of Creole, French, English, and Spanish, plays several instruments such as guitar, keyboard, bass, and drums, and excels in many different musical genres such as Compas, Zouk, Dancehall, Reggae, R&B, and Hip-Hop; and

WHEREAS, MIKABEN participated in the annual Christmas show hosted by Telemax and launched his first song in 1999 titled ‘Nwel Tristes’, recorded and released his first album titled ‘VWAYAJ’ in 2000, and performed on international stages throughout the world including at the Olympia and Zenith in Paris, the Cultural Center of the Ivory Coast, the Hoogstraten Festival in Belgium, Joe’s Pub in New York City, and the Miami Compas Festival; and

WHEREAS, MIKABEN had his song ‘Ou Pati’ chosen for the Haitian Troubadour project, created the successful group Krezi Mizik, and inspired the creation of the poignant Tisouf Foundation after the 2010 earthquake in Haiti to bring joy to children.

WHEREAS, MIKABEN is the son of famous singer Lionel Benjamin and has collaborated with many artists including Carimi, T-Vice, Leila Chicot, Kreyol La, Belo, Stanley Georges, Alan Cave, Izolan, Olivier Duret, J. Perry, and Wesli.
