# **Introduction**

#### Points of Interest:

- 1. Undisclosed assets worth more than \$300,000
- 2. Husband In Federal Prison for Wire Fraud, Money Laundering, Aggravated Identity Theft
- 3. Intentionally leaving assets off her financial disclosure while running for StateWide Office. (Grounds for disqualification)
- 4. Possible misuse of nonprofit funds in regards to Ester's House and her Property in NY
- 5. Husband sued by mayor of North Miami for fraud.
- 6. Intentional strategic use of maiden name and married name to obscure financial assets

Naomi Esther Blemur, formerly Leriche, was born April 18th, 1979¹ in Miami, FL to Haitian immigrants. She then moved to and was raised in Brooklyn, NY.² Naomi is currently a registered Democrat to the FL Democratic Party in Miami-Dade County as of 04/03/2015. She is registered at her home address, 2301 Laguna Circle, North Miami, FL 33181.³ Prior to being registered in Florida, Naomi was a member of the New York Democratic Party, under the name Naromie Leriche, at her address 216-20 115 Terrace, Cambria Heights, NY 11411.⁴ The deed to Naomi's (Naromie) New York property was purchased in 2006 under the name Naromie Leriche for \$300,000 from Anthony Attale and Gemma Attale.⁵ The New York property is now listed as the location for Esther's House of Hope, Inc, which was started by Leriche in 2008.⁶ In this memo, you will find information on Naomi's failure to report her property assets correctly on her financial disclosure, her name change, her husband Anis' arrest and conviction for fraud, money laundering, and aggravated identity theft, and her suspected connections to those business dealings.

## <u>Unreported Property/Financial Disclosure Violations</u>

Naomi owns a New York property which she claims is the base of operations for a non-profit, Esther's House of Hope, Inc. The property, however, was not bought by Esther's House, but rather by Naomi herself, and therefore qualifies as an asset.

- The house was bought in 2006 and listed as a "residential dwelling-single family" at the time of sale. It was sold for \$300,000. Below is a screenshot of the sale agreement between the two parties.<sup>7</sup>
- Further information needed as to whether Esters House financially compensated Naomi for use of the property in NY. If so, this could be grounds for criminal prosecution for misuse of non-profit funds.

While the name on the sale document is Naromie Leriche, and Naomi's filing name for Agriculture Commissioner is Naomi Blemur, below is the evidence which links her names together and proves Naomi (Leriche) Blemur is the same person as Naromie Leriche. This is a combination of voter records, property records, LinkedIn mentions, books sales, and other public records which confirm this assertion.

- Naomi was born 04/18/1979 according to her Florida voter registration records<sup>9</sup>, which is the same birthday used to find Naromie Leriche's voter registration records in New York<sup>10</sup>
- Naomi also claimed "Leriche and Associates," a consulting firm under her maiden name, on her Form 6 Public Financial Disclosure she filed to qualify for the FL Commissioner of Agriculture race<sup>11</sup> Below is a picture of this document.

- On Naomi's LinkedIn, her only endorsement received is from Denise Finnegan, who names her as "Naromie". Denise and Naomi studied together in 2013. 13
- Naomi self-published her book "The Process to Purpose" in 2010 <sup>14</sup> which was then published again in 2015 by Digital Publishing of Florida, Inc. <sup>15</sup> The "About the Author" section names Naomi as the CEO of Esther's House <sup>16</sup>. Included below is the cover of the book, featuring a picture of Naomi as well as the name "Naromie Leriche".



Now, once again tying all of this back to Naomi's financial disclosure reporting violation, Naomi opened and operated Esther's House as the CEO. Esther's House is a non-profit registered to the NY property address owned by Naomi: 216-20 115 Terrace, Cambria Heights, NY 11411. Since Naomi bought this property as an individual, it should qualify as a personal asset, required by the Florida State Statutes to be disclosed on a Form 6 filing, regardless if it is being used to host a non-profit entity.

### **Anis Blemur In Prison/Civil Suits**

Naomi is married to Anis Blemur, a former Democratic State Senate candidate and real estate broker, who was sentenced to over 7 years in prison in 2019. <sup>19</sup> Anis was charged with wire fraud, money laundering, and aggravated identity theft, and plead guilty to several counts of each according to US Appellate Court documents <sup>20</sup>

Blemur has been sued in civil proceedings by multiple parties. Dr. Joseph Smith, the first medicinal doctor elected to Mayor of North Miami<sup>21</sup>, may be the most notable

Plaintiff. Dr. Joseph brought a suit with one count each of breach of contract, fraud in the inducement, and civil theft.<sup>22</sup>



### SFL Real Estate Investor & Senate Candidate Steals \$1,600,000

Anis Blemur an author, property investor & former Senate State candidate is languishing in jail after being convicted of stealing money from predominantly the South Florida Haitian Community. He had plead guilty in April of this year to wire fraud, money laundering and aggravated identity theft.

One of his many basic scams was to solicit homebuyers and persuade them to place their

Investigators say Blemur, who was born in Haiti, stole at least \$1.6 million from his victims, most of them members of South Florida's Haitian community. In general, Blemur took money from would-be real-estate investors and used the funds for his own personal expenses. During the investigation, federal agents uncovered even more fraud: Blemur had used his victims' personal information to apply for 26 credit cards.
