18 Defendant on August 22, 2001, and that the Defendant was duly served with process in

21 and it further appearing to the Court that the Defendant's Default was duly taken by the  
22 Plaintiff and entered on March 18, 2002, and the Court having read the Default and the  
23 supporting Affidavit and finding that the allegations of Plaintiff's Complaint are true, and  
24 that the Defendant is obligated to the Plaintiff on Six (6) credit instruments negotiated to  
25 the Plaintiff on or about September 17, 1999, September 18, 1999, September 19,  
26 1999, and November 2 1999, in the total amount of TWENTY-EIGHT THOUSAND AND  
27 NO/100 DOLLARS (\$28,000.00).

3 Defendant subsequently paid to Plaintiff, the sum of \$500.00, thereby reducing  
4 Defendants indebtedness to Plaintiff in the amount of \$27,500.00. By virtue of  
5 executing the credit instruments and credit application, Defendant agreed to pay  
6 interest on the amount eighteen percent (18%) per annum, as well as pay all costs  
7 of collection including attorney's fees, no part of which has been paid, and the Court  
8 being fully advised in the premises, and good cause appearing therefor,

9 IT IS HEREBY ORDERED that Plaintiff, BELLAGIO, a Limited Liability  
10 Company, ("Bellagio") successor in interest to Bellagio, a Nevada corporation, be, and it  
11 is hereby awarded judgment against the Defendant, MICHAEL A. GATES, , in the  
12 amount of TWENTY-SEVEN THOUSAND FIVE HUNDRED AND NO/100 DOLLARS  
13 (\$27,500.00), interest thereon at the contract rate of eighteen percent (18%) per annum  
14 from November 22, 1999 until fully satisfied, along with reasonable attorney's fees in  
15 the amount of \$ 6875.00 and costs of suit in the amount of \$264.00






