The undersigned certifies and swears that he/she has just and reasonable grounds to believe, and does believe that the above named Defendant committed the following violation of law. The Person taken into custody... [X] was observed by DEANNA MEISEL & LIA MORELL who told OFC. FERRAILO that he/she saw the arrested person commit the below acts. [X] confessed to OFC. FERRAILO admitting to the below facts. [X] was found to have committed the below acts, resulting from my (described) investigation. On the 10 day of May, 2016 at 16:12 (Specifically include facts constituting cause for arrest.)

The following incident occurred in the city of Delray Beach, Palm Beach County, FL. On 5/10/16 at 4:12 PM, I responded to Stein Mart (1855 S Federal Hwy) in reference to an in custody employee retail theft case. I met with the asset protection agents Deanna Meisel and Lia Morell. I was informed that the defendants, Jennifer C Hillmon and Marsha Jean Baptise, have been conducting fraudulent transactions on the cash registers and placing unpaid for merchandise in bags and exiting the store with the stolen merchandise. Meisel provided me with a surveillance CD which showed several of these transactions. The dates and times of the incidents were as follows: 4/9 from 6:19 PM to 6:32 PM; 4/23 from 9:04 PM to 9:09 PM; and 5/2 from 4:56 PM to 5:03 PM. On 4/9 Jean Baptise was the role of the cashier and Hillmon received the stolen items. On 4/23 Hillmon was the cashier and Jean Baptise received the stolen items. On 5/2 Jean Baptise was the role of the cashier and Hillmon received the stolen items. The items stolen included men`s and women`s clothing and fragrances for a total loss of \$383.51. [REDACTED] Meisel provided me a copy of the statements. Meisel and Morell completed DBPD sworn written statements regarding the thefts. Meisel informed me that the company would be following up with additional charges at a later date for other crimes committed by the defendants. While still on scene I took Hillmon into the lunch room and read her Miranda Warnings to which she waived her rights. I asked Hillmon why she committed the thefts and she told me she first started to steal from the company because she was unhappy with her job. She told me she made "poor choices" which led her to continue to do fraudulent transactions and take items which she did not pay for. Hillmon said she was also

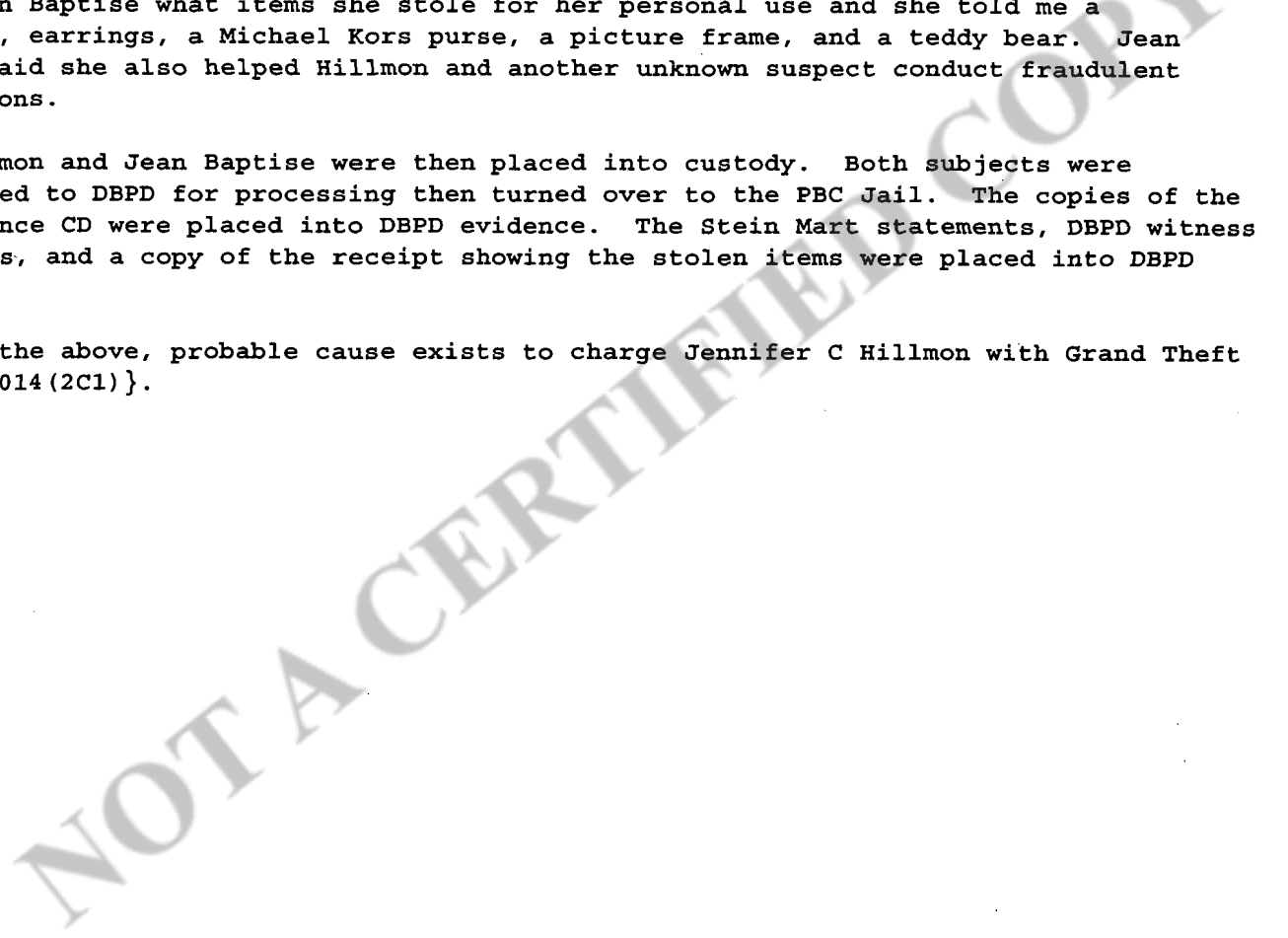

pressured to do the fraudulent transactions by her co-worker Jean Baptise.

I then took Hillmon back to the main office and escorted Jean Baptise to the lunch room so I could question her. I read Jean Baptise her Miranda Warnings and she waived her rights. I asked Jean Baptise why she committed the alleged crimes and she told me she was pressured by Hillmon. Jean Baptise said she made "bad choices" and began crying. I asked Jean Baptise what items she stole for her personal use and she told me a comforter, earrings, a Michael Kors purse, a picture frame, and a teddy bear. Jean Baptise said she also helped Hillmon and another unknown suspect conduct fraudulent transactions.

Both Hillmon and Jean Baptise were then placed into custody. Both subjects were transported to DBPD for processing then turned over to the PBC Jail. The copies of the surveillance CD were placed into DBPD evidence. The Stein Mart statements, DBPD witness statements, and a copy of the receipt showing the stolen items were placed into DBPD records.

Based on the above, probable cause exists to charge Jennifer C Hillmon with Grand Theft {FSS 812.014 (2C1)}.
