NARRATIVE

On January 21, 2026 I made contact with Mayor, Michael Joseph, in reference to a verbal threats that occurred at Commission Chambers on the second floor in City Hall (17101 NE 19 AV). Mayor Joseph stated that on January 20, 2026 at around 10:40pm he left the dias and began walking towards the exit door when all of a sudden he was approached by Barbara Kramer (OF). Mayor Joseph stated that Barbara said, " I'm going to get you! I'm going to hurt you and there's nothing the police can do about it." Mayor Joseph advised that he was bewildered and threw up his hands and exited the door. Mayor Joseph went on to say that he felt threatened and was in fear for his life.

I made contact with witness, Linda Joseph, via phone and she advised that she witnessed Barbara Kramer make a beeline towards Mayor Joseph as he was walking towards the exit. Linda further stated that Barbara Kramer began verbally assaulting Mayor Joseph. Linda stated that she only heard Barbara say, " they can not help you." Linda then observed Mayor Joseph put his hands in the air and exited the door.

Investigation revealed that on January 20, 2026 at approximately 2042hrs upon the conclusion of a scheduled commission meeting, Mayor Joseph was walking towards the exit door that's near the city commission dais. Barbara Kramer also walked towards the same door and then stopped and waited for Mayor Joseph. As Mayor Joseph got closer Barbara said something which caused Mayor Joseph to raise his hands in the air and back out of the door. The interaction lasted about 10 seconds.

The incident was captured on the video cameras of the Commission Chambers. A statement form was completed by Mayor Joseph and Linda Joseph advised that she will complete one at a later time.

The Detective Bureau was notified and will further investigate the matter.

Mayor Joseph was issued a case number.

Kramer stated that she was happy that the commission will be voting to look into the treatment of city staff and the failure to follow protocols. Due to being excited she approached the city mayor Michael Joseph while walking out and sarcastically stated "are you happy?" "I'm happy they're going to start to looking into you". After her statement Mayor Michael Joseph put his hands up and stated "not me".

In reaction to his actions by putting his hands up she stated "oh what are you gonna do? Get more police detail!" and walked away. According to B. Kramer she did not threaten him and her statements were all sarcastic and made jokingly. When asked if anyone else was around to witness the interaction she stated that no other people were around. No further statements were given.
